TERMS & CONDITIONS:

1. All the General stalls will be of a standard size: 4mx4m White frame marquee, except for food stalls which is 6mx6m. The 4x4 stall is R7500, 6x6 R12 000 and 6 x12 R24 000
2. The rental must be paid upfront to ensure booking is confirmed. All outstanding debt must be settled before the stall is allocated. Closing date for upfront payments is 2nd October 2023.
3. 1x Table and x2 chairs will be provided. A Fee of R50 per additional table and R20 per additional chair will be charged and will be paid up-front.
4. Food stall holders – please supply health certificates and please ensure you have a fire extinguisher and a fire blanket at the stall.
5. All equipment used for cooking must be made available for inspection prior to the opening of the festival. Non-compliant equipment will not be allowed on site.
6. Lighting in each stall will be provided, but for and electricity point, there will be a cost of R200 per one phase plug point and R500 per three phase.
7. Only approved items and products will be allowed to be sold. Please specify in detail **ALL** items to be sold.
8. Stalls will be allocated to each stall holder prior to 31st October 2023. **NO CHANGES ON SITE.**
9. The Durban Diwali Festival has the right to reserve trading. On the day of the festival you may be asked to cease selling any goods or category of goods not specified in this application.
10. Closing date for application forms is Friday, 6th October 2023
11. Applications may be refused at the sole discretion of the committee of the SAHMS. All decisions will be final and no correspondence will be entered into.
12. All relevant applicants will be contacted with the relevant outcome of this application and the Diwali Festival Rules and Regulations. Failure to comply will result in the stall being closed down for the duration of the festival.
13. All stall holders are responsible to comply with municipal by laws and regulations.
14. There will be **NO REFUNDS** for any reason whatsoever (including inclement weather).
15. Designated Stall Areas: Lessees are strictly bound to their designated stall areas and are not permitted to trade beyond the area allocated to them. This includes, but not limited to, common walk areas, aisles, other lessees designated stall areas, the main entertainment marquee, the food court and car parks.
16. Noise pollution: Use of public address system and speakers to play music shall be limited to the lessee's designated stall area. The noise level must be contained within the lessee's designated stall area. Any lessee who violates this term shall have his equipment confiscated.
17. The SAHMS does not accept responsibility for any losses, damages or theft.
